



MEMORANDUM OF UNDERSTANDING

This **Memorandum of Understanding** (hereinafter called as the 'MOU') is entered into on this 21st day of September, Two Thousand and Twenty (21-9-2020), by and between **JSS College for Women, Kollegal, the First Party** represented herein by its **Principal – Prof. Umesha** (hereinafter referred as '**First Party**', the institution which expression, unless excluded by or repugnant to the subject or context shall include its successors – in-office, administrators and assigns).

AND

JSS COLLEGE FOR WOMEN, CHAMARAJANAGAR and represented herein by its **PRINCIPAL Sri. K S Mariswamy** (hereinafter referred to as "**Second Party**", which expression, unless excluded by or repugnant to the subject or context shall include its successors – in-office, administrators and assigns).

(First Party and Second Party are hereinafter jointly referred to as 'Parties' and individually as 'Party') as

WHEREAS:

- First Party is a Higher Educational Institution named: **JSS COLLEGE FOR WOMEN, KOLLEGAL**
- **JSS COLLEGE FOR WOMEN, CHAMARAJANAGAR** Second Party is a Higher Education Institution name
- First Party & Second Party believe that collaboration and co-operation between themselves will promote more effective use of each of their resources, and provide each of them with enhanced opportunities.
- The Parties intend to cooperate and focus their efforts on cooperation within area of higher education.
- Both Parties, being legal entities in themselves desire to sign this MOU for advancing their mutual interests.

NOW THEREFORE, IN CONSIDERATION OF THE MUTUAL PROMISES SET FORTH IN THIS MOU, THE PARTIES HERE TO AGREE AS FOLLOWS:

CLAUSE 1

CO-OPERATION

- Both Parties are united by common interests and objectives, and they shall establish channels of communication and co-operation that will promote and advance their respective operations within the **Institution** and its related wings. The Parties shall keep each other informed of potential opportunities and shall share all information that may be relevant to secure additional opportunities for one another.
- First Party and Second Party co-operation will facilitate effective utilization of the intellectual capabilities of the faculty of First Party providing significant inputs to them in developing suitable teaching / training systems, keeping in mind the needs of the industry, the Second Party.
- The general terms of co-operation shall be governed by this MOU. The Parties shall cooperate with each other and shall, as promptly as is reasonably practical, enter into all relevant agreements, deeds and documents (the 'Definitive Documents') as may be required to give effect to the actions contemplated in terms of this MOU. The term of Definitive

Documents shall be mutually decided between the Parties. Along with the Definitive Documents, this MOU shall represent the entire understanding as to the subject matter hereof and shall supersede any prior understanding between the Parties on the subject matter hereof.

CLAUSE 2

SCOPE OF THE MOU

- The budding graduates and postgraduates from the institution could play a key role in technological up-gradation, innovation and competitiveness of an industry. Both parties believe that close co-operation between the two would be of major benefit to the student community to enhance their skills and knowledge about legal troubles and difficulties.
- **Curriculum Design:** Second Party will give valuable inputs to the First Party in teaching / training methodology and suitably customize the curriculum so that the students fit into the areas of industry.
- **Training & Visits:** Interaction between the institutions will give an insight in to the latest developments / requirements of the academic activities; the Second Party to permit the Faculty and Students of the First Party to visit its facilities and also involve in Training Programs for the First Party. The training and exposure provided to students and faculty through this association will build confidence and prepare the students to have a smooth transition from academic to working career. The Second Party will provide its Labs / Workshops / Industrial Sites for the hands-on training of the learners enrolled with the First Party.
- **Research and Development:** Both Parties have agreed to carry out the joint research activities in the fields of Social Science.
- **Guest Lectures:** Second Party to extend the necessary support to deliver guest lectures to the students of the First Party on the technology trends and in house requirements.
- **Faculty Development Programs:** Second Party to train the Faculties of First Party for imparting training as per the industrial requirement considering the National Occupational

Standards in concerned sector, if available.

- Both Parties to obtain all internal approvals, consents, permissions, and licenses of whatsoever nature required for offering the Programmes on the terms specified herein
- There is no financial commitment on the part of both the parties. If there is any financial consideration, it will be dealt separately.

CLAUSE 3

VALIDITY

This Agreement will be valid for 5 (Five) years. Either parties can terminate this agreement with immediate effect by a written notice (can be in the form of an email). In the event of Termination, both parties have to discharge their obligations.

CLAUSE 4


RELATIONSHIP BETWEEN THE PARTIES

Neither Party shall have, nor represent itself as having, any authority under the terms of this MOU to make agreements of any kind in the name of or binding upon the other Party, to pledge the other Party's credit, or to extend credit on behalf of the other Party.

Any divergence or difference derived from the interpretation or application of the MoU shall be resolved by dialogues.



Either Party may terminate the MoU at any time during the term by the provision of three months written notice to the other party.

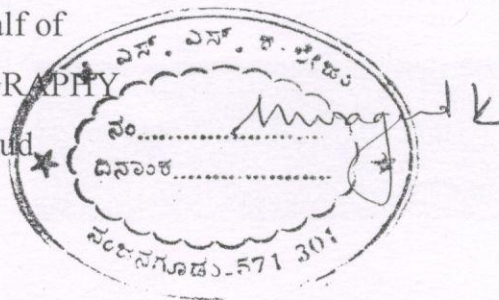

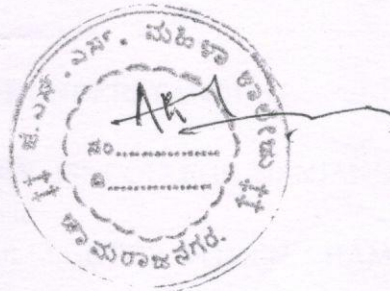

About JSS College for Women Chamaranagara

JSS College of Arts, Science and Commerce was established in 1967 with B.Sc programme. It was a co-education institution till it was converted into Women's College in the year 2000. It is a multi faculty, Grant in Aid College, Affiliated to the University of Mysore, Recognized by UGC under 2(F) and 12(B) by the Govt of Karnataka. In the third cycle (2017) NAAC assessment the College has been Re-Accredited "A" Grade with CGPA 3.02, Proposal has been submitted to NIRF for annual grading of College. The College celebrated its Golden Jubilee during the year 2017-18 with all grandeur. Gradually the college started BA, B.Com, BBA and BCA programmes.

About Youth for Seva (YFS).

Youth for Seva (YFS), founded in April 2007, is a nation-wide volunteering movement that inspires youth to volunteer, and provides them with meaningful opportunities to serve the community.

The goal of YFS is to support schools, destitute shelters, government hospitals and other organizations in the social sector through volunteers who can help them mitigate some of




their shortcomings and challenges. Volunteering is made easy and customized to the individual's interests, time availability and skill sets.

YFS aims to create positive change agents in the society, through the culture of volunteering.

NOW THIS MEMORANDUM OF UNDERSTANDING WITNESSETH AS FOLLOWS

I. Scope of this MoU

A. Joint Responsibility.

1. Cooperation: Both Parties are united by common interests and objectives, and they shall establish channels of communication and co-operation that will promote and advance their respective operations within their related constituents. The Parties shall keep each other informed of potential opportunities and shall share all information that may be relevant to secure additional opportunities for one another.

General terms of co-operation shall be governed by this MOU.

The Parties shall cooperate with each other and shall, as promptly as is reasonably practical, enter into all relevant agreements, deeds and documents (the 'Definitive Documents') as may be required to give effect to the actions contemplated in terms of this MOU. The term of Definitive Documents shall be mutually decided between the Parties. Along with the Definitive Documents, this MOU shall represent the entire understanding as to the subject matter hereof and shall supersede any prior understanding between the Parties on the subject matter hereof.

2. NMMS: The National Means cum Merit Scholarship Examination, also known as NMMS Exam, is sponsored by the Central Government. The examination is conducted by the local authority. To prevent the dropping out of economically backward students from school at class VIII and to encourage them to complete their education till the secondary stage, the exam seeks to identify meritorious students and fund their education expenses. **JSS College for Women Chamarajanagara** shall encourage and enroll hundred (100) students to



volunteers for six (6) hours and three (3) days in a week over a period of three (3) Months during every calendar year. Student Volunteers from **JSS College for Women Chamaranagara** will attend training programs and later train children on Mental Aptitude Test. (MAT) and Scholastic Aptitude Test. (SAT). Volunteers will support children train, appear and crack the NMMS examination. Youth for Seva shall train the student volunteers on NMMS and assign nearby schools to render training by student volunteers to government or aided school children.



3. Volunteer Base and Internship: A strong base of not less than fifty 50 student volunteers and a faculty mentor/supervisor under the Youth for Seva forum/club will be formed to render volunteering service. Student volunteers will participate in the YFS volunteer service activities as and when requested, based on the need for volunteer support required to address social issues or social developmental activities. Not less than eighty (80) students will take up full time internship program with youth for seva for a duration of not less than 1 (one) Month during every calendar year.

4. Joint Publications & Exchange of Knowledge Resource: Joint publications of research articles, papers, books to develop research aptitude and to contribute to the world of knowledge. Share books, audio-videos, publications, reports and other teaching aids. Use each other's infrastructure such as auditorium, playground, and classrooms to host necessary events.

5. Community Oriented Development Activities: Youth for Seva will support **JSS College for Women Chamaranagara** towards addressing the local community needs in the area of Health, Education, Livelihood, and Environment. A list of eight various activities/interventions/events will be planned and executed during every academic calendar year.

B. Activities under the scope of Sarada Vilas Education Institute. (First Party)

- 1. JSS College for Women Chamaranagara** will work as a knowledge partner and will be the hub for Research, Training Demonstration and Dissemination of information through the volunteers.

2. JSS College for Women ChamaraJanagara will create Youth for Seva Volunteer base and provide students with internship opportunity at youth for Seva.
3. JSS College for Women ChamaraJanagara plan and execute community oriented development activities in the area of Health, Education, Livelihood, and Environment.

C. Activities under the scope of YFS (Second Party)

1. Students from JSS College for Women ChamaraJanagara will play a key role in participating in the Skill Development, Volunteerism and community service based activities. YFS will mentor and initiate the students for involvement in these activities.
2. Youth for Seva will host student volunteers and internship program through its intervention programs in the local region.
4. Implementation partner community oriented development activities in the area of Health, Education, Livelihood, and Environment.

II. FINANCIAL COMMITMENTS.

There is no financial commitment on the part of the JSS College for Women ChamaraJanagara the First Party to take up any programme mentioned in the MoU. If there is any financial consideration, it will be dealt separately. Similarly there are no financial or monetary commitments on the part of the YOUTH FOR SEVA- NGO the Second Party to take up any programme mentioned in the MoU. If there is any financial consideration, it will be dealt separately.

III. INTELLECTUAL PROPERTY

Nothing contained in this MoU shall, by express grant, implication, Estoppel or otherwise, create in either Party any right, title, interest, or license in or to the intellectual property of the other Party.

IV. RELATIONSHIP BETWEEN THE PARTIES



It is expressly agreed that **JSS College for Women Chamarajanagara** and **YOUTH FOR SEVA- NGO** are acting under this MOU as independent contractors, and the relationship established under this MOU shall not be construed as a partnership. Neither Party is authorized to use the other Party's name in any way, to make any representations or create any obligation or liability, expressed or implied, on behalf of the other Party, without the prior written consent of the other Party. Neither Party shall have, nor represent itself as having, any authority under the terms of this MOU to make agreements of any kind in the name of or binding upon the other Party, to pledge the other Party's credit, or to extend credit on behalf of the other Par.

V. AMENDMENTS TO THE MOU:

No amendment or modification of this MoU shall be valid unless the same is made in writing by both the parties or their authorized representatives and specifically stating the same to be an amendment of this MoU. The modifications / changes shall be effective from the date on which they are made / executed unless otherwise agreed to.


VI. ASSIGNMENT OF THE MOU

The agreement will be considered null and void and subject to termination by default if there are no activities organized or hosted by either of the parties for three consecutive months in a calendar year from the date the MoU is signed by both the first and second parties. 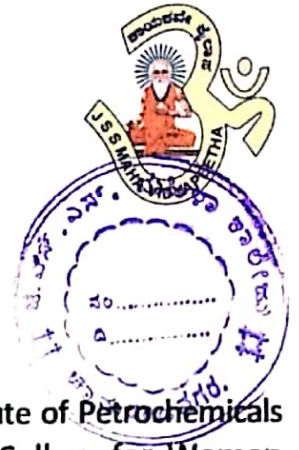




